



# SSID LEA User Agreement

## Instruction Sheet

### Steps

1. Complete the appropriate SSID User Agreement Form(s).
2. Read SSID System Usage Guidelines by the USBE Legal Department (next page).
3. Complete, sign, and have approved, the LEA User SSID Website Access Request Form.
4. If you have a LEA SSID Administrator; forward the form to your LEA SSID Administrator. They should log in and create the user account on the SSID website. They will then complete and sign the LEA Administrator section and return the form to the user.
5. If you do not have a LEA SSID Administrator: Please have someone with authority sign the form in the LEA Administrator section of the form (i.e., principal, director, etc...) and return the form to the user.
6. Scan and email an electronic copy to [ssidhelp@schools.utah.gov](mailto:ssidhelp@schools.utah.gov).
7. SSID Support will review the form(s) and create, or approve the user account created by the LEA SSID Administrator.
8. SSID Support will then contact the user with their user ID and password.
9. The requester will login to the [SSID website](#) with a one-time password and change the password.

## SSID System Usage Guidelines

Dear Local Education Agency Administrator:

Thank you for your interest in the USBE SSID website. Before requesting access to the site, please be aware that access is governed by the Federal Family Education Rights and Privacy Act. Per FERPA, access to student records maintained on this site is limited to “officials” within your local education agency who have a “legitimate educational purpose.” This means;

- Volunteers may NOT have access to the SSID website.
- Access must be limited to those who need the information for legitimate educational purposes. Personal use of the information is prohibited.
- Information that is down-loaded, printed, or saved must be destroyed when it is no longer needed to identify students.
- Information about students in other districts or charter schools should not be down-loaded, printed, or saved for any reason.
- Your password may not be shared with anyone else.

Violation of FERPA may result in the loss of federal funding. On the state level, violation will result in the termination of the violator’s access to the SSID website.

Please help us maintain the integrity and usability of the website by limiting access to the fewest possible number of individuals.
