

STATE AGENCY ADMINISTRATIVE REVIEW SUMMARY

Weekly minimum requirements of meat/meat alternate were not met for all age/grade groups, and daily meat/meat alternate requirements were not met for one age/grade group due to miscalculation of crediting. Crediting could not be calculated for several items due to lack of documentation.
