

# Planning Requirements and Recommendations for K-12 School Reopening

## Addendum to Utah Leads Together Color-coded Guidelines

*Updates instituted August 6, 2020 highlighted in red*

### Introduction

The Governor's Office of Management and Budget requested the Utah State Board of Education (USBE) propose an addendum to the Utah Leads Together Color-coded Guidelines. The purpose of the addendum is to define the elements and itemize the requirements Local Education Agencies (LEAs) would need to incorporate into their individual plans to safely reopen schools to in-person learning in fall 2020. ### Plan Requirements

Local education agencies (LEAs) are required to develop comprehensive reopening plans that are **approved by the local school board or charter school governing board in an open and public meeting and made available to the public on the local education agency's website, and each school's website, by August 1, 2020.** Plans must address the following elements:

- Repopulating Schools
  - Communication and Training
  - Accommodating Individual Circumstances (e.g. high-risk, personal decisions)
  - Enhanced Environment Hygiene & Safety
  - School Schedules
- Implementation of Mitigation Actions in School Settings (e.g., Classrooms, Transitions, Office Spaces, Transportation, Restrooms, Cafeterias)
  - Apply a set of principles and levers to mitigate risk of spread of COVID-19 across school settings
- Monitoring for Incidents
- Containing Potential Outbreaks
- Temporarily Reclosing (if necessary)

The tables below articulate minimum requirements that plans developed by LEAs must address. Requirements were determined to be in the best interest of Utah's students and faculty to create a consistent, state-wide standard of expectation. Recommendations provide considerations to guide local planning efforts and may be adapted to fit the unique circumstances of each LEA, school, and individual classroom.

# School Reopening Plans: Requirements and Recommendations

USBE will provide guidance and support on completing plans that comply with these requirements, including a framework for assessing risk levels of various school settings and incorporating appropriate levers to mitigate risk. USBE will also provide webinars on applying the framework.

LEAs will be required to use a USBE planning template as a mechanism to support and ensure LEAs apply a principles-based, problem-solving framework to assess and mitigate risk from COVID-19. LEAs must submit the planning template to USBE as an assurance by August 1, 2020.

Requirements outlined in this document are in place as long as a Governor’s Executive Order is in effect.

## Elements of Plans – Requirements and Recommendations

### Repopulating Schools

| <p><b>Enhanced Environment Hygiene &amp; Safety</b></p> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Develop protocols for implementing an increased cleaning and hygiene regimen</li> <li>- Per <a href="#">State Public Health Order</a>,<sup>1</sup> each individual, including an employee, student, or visitor, on school property or on a school bus is required to wear a face covering. See the State Public Health Order for exceptions based on individual circumstances and for certain activities.</li> <li>- Make hand sanitizer, disinfecting wipes, soap and water, or similar disinfectant readily available to staff/students/visitors in controlled environments to ensure safe use</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Implement hygiene standards as a part of regular instruction</li> <li>- Assist local health department should they require contact tracing</li> <li>- Clean and disinfect frequently touched surfaces and items at least daily (doorknobs, desks, computers, sporting equipment, shared supplies, etc.)</li> <li>- Locally determine what constitutes an adequate hygiene and prevention inventory: PPE supplies, face coverings, sanitizer, soap, etc.</li> </ul> |

| <b>School Schedules</b> | <p>Recommended:</p> <ul style="list-style-type: none"> <li>- When considering strategies that attempt physical distancing by reducing the number of students on-campus, consider financial hardships and alternative childcare arrangements for single parent families or for families in which both parents must work outside the home and strain on childcare capacity.</li> </ul>                                |

### Implementation of Mitigation Tactics in School Settings<sup>2</sup>

Each LEA’s plan must apply a set of principles and levers to mitigate risk of spread of COVID-19 across each of the school settings below. In the following table, USBE, in coordination with state and local health and education leaders, has outlined mitigation tactics by school setting. The first set of tactics are labeled as state-wide requirements. Requirements were determined to be in the best interest of Utah’s students and faculty to create a consistent, state-wide standard of expectation. The second set of tactics are labeled as recommended. These tactics are recommended but may be adapted to fit the unique circumstances of each LEA, school, and individual classroom. In all settings, decisions should be rooted in principles to mitigate the spread of the coronavirus and respond to the situational characteristics of that space.

Note that per [State Public Health Order](#),<sup>3</sup> each individual, including an employee, student, or visitor, on school property or on a school bus is required to wear a face covering. See the State Public Health Order for exceptions based on individual circumstances and for certain activities.

| <b>Classrooms</b> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Develop and provide educator training on implementing strategies to identify and mitigate risk in a classroom setting</li> </ul> |

| School Setting    | Mitigation Tactics  |

|                   | <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Assign seats and/or small groups to support contact tracing</li> <li>- Keep the same students and teachers or staff with each group to the greatest extent practicable</li> <li>- Maximize space between seating and desks (acknowledging that 6 feet of distance between desks is not feasible for most Utah classrooms)</li> <li>- Seat students facing forward</li> <li>- Establish separation of students through other means, such as plexiglass barriers, if practicable</li> <li>- Identify and use large spaces (auditoriums, gyms, and outdoors) to maximize distancing</li> </ul> <p>Move nonessential furniture and equipment out of classrooms to increase distancing footprints</p>   |
| Transitions       | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Identify high traffic areas and apply floor markings or signage to direct traffic</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Stagger or limit transitions to support contact tracing and minimize interactions with multiple groups</li> <li>- Increase time for transitions</li> <li>- Minimize and monitor congregation of students</li> <li>- Provide cups or alternative procedures to minimize use of water fountains when at all possible</li> <li>- Prop doors open to reduce touch</li> <li>- Clean high-touch surfaces after transition periods</li> </ul>   |
| Entry/Exit points | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Designate entry/exit flow paths to minimize congestion</li> <li>- Limit nonessential visitors and volunteers to campuses and programs; each school is to determine essential versus nonessential</li> <li>- Establish protocols for any visitors and non-regular staff, including at a minimum temperature checking and the wearing of face coverings</li> <li>- Establish protocols for drop-off/pick-up and communicate updates and expectations to families</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Consider protocols for visitors, including sign-in and sign-out, locations being visited, screening, calling front office before entering, etc.</li> <li>- Make available hand sanitizer and/or hand washing stations upon exit/entry</li> <li>- Post visible signage to encourage physical distancing</li> <li>- Use both entrance and egress to avoid clustering at single points of entry</li> </ul> |

| <p><b>Transportation</b></p> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Implement strategies to ensure driver safety</li> <li>- Develop protocols for minimizing mixing of students from different households and regularly cleaning and disinfecting seats and other high-touch surfaces</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Assign seating to support contact tracing</li> <li>- Maximize physical distancing, acknowledging that physical distancing of 6 feet or greater is not feasible in many instances</li> <li>- Plexiglass around driver</li> </ul>  |
| <p><b>Restrooms</b></p>      | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Provide education and display signage on proper hand hygiene</li> <li>- Create schedule for cleaning high-touch areas (e.g., faucets, paper towel dispensers, door handles)</li> <li>- Ensure PPE (gloves, masks) is available for staff providing support in restrooms, including custodians</li> <li>- Provide training for proper cleaning protocols for COVID-19</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Ensure proper airflow and ventilation through building engineering</li> <li>- If students are grouped by the same hallway/floor/grade level, designate restroom for each cohort</li> <li>- Minimize number of individuals in a restroom</li> <li>- Systems to reduce simultaneous, multiple users and thus reduce contact with others</li> <li>- Place markings on floor to encourage physical distancing when waiting to use facilities</li> <li>- Increase barriers between stalls/urinals</li> <li>- Block off every-other stall</li> <li>- Establish a rotating monitor to frequently ensure soap is available</li> </ul> |
| <p><b>Cafeterias</b></p>     | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Mark spaced lines and designate serving line flow paths</li> <li>- Remove self-service salad bars and buffet</li> <li>- Student hand hygiene routines (i.e., hand washing or sanitizer) before and after meal services</li> <li>- Increase cleaning and disinfecting of high-touch areas</li> </ul>  |

|   | <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Consider staggering lunch hours to reduce number of students at one time</li> <li>- Students assigned to cafeteria times or areas by cohort</li> <li>- Use outdoor eating areas for increased circulation</li> <li>- Decrease lunch times</li> <li>- Record seating and attendance to support contact tracing</li> <li>- Use disposable plates, utensils, etc. when possible</li> <li>- Prepare and distribute sack or box lunches for students to eat in homerooms or outside</li> <li>- Use paper cups and personal bottles instead of water fountains</li> </ul>  |
| <p><b>Large Group Gatherings (e.g., assemblies, recitals)</b></p> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- LEAs ensure group gatherings are organized with health and safety principles and requirements in place and, as needed, in consultation with local health departments</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Explore limiting and/or canceling nonessential assemblies, recitals, dances, etc. or reschedule as virtual gatherings</li> <li>- Broadcast to home rooms or hold multiple sessions of the same assembly with smaller groups</li> <li>- Record attendance and seating location of large gatherings to support contact tracing</li> <li>- Create alternate plans for whole staff gatherings such as virtual meetings</li> <li>- At special events, consider screening/non-contact temperature testing of adults who will be direct participants and have close contact with students</li> <li>- Include mitigation strategies for safety drills (i.e., fire, lockdown, earthquake)</li> </ul> |
| <p><b>Unique Courses with Higher Risk of Spread</b></p>           | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- LEAs must identify courses that would be more at risk and make plans with support from local health departments (as needed) to mitigate the risks</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Consider limiting and/or canceling nonessential assemblies, recitals, dances, etc. or reschedule as virtual gatherings</li> <li>- Choir is an inherently high-risk activity due to the increased level of respiratory output; consider layering several other strategies to mitigate, including conducting in outdoor spaces, space at least 6 feet</li> </ul>   |

| <p>Recess and Playgrounds</p>  | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- LEAs ensure recess and playgrounds are managed with health and safety principles and requirements in place and, as needed, in consultation with local health departments</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Alternate recess, playground time, use of outdoor spaces</li> <li>- Disinfect playground/gym equipment between each use</li> </ul>  |
| <p>Special Education, Related Services, or School Counseling (e.g. School Psychologist, Speech Language Pathologist, Occupational Therapist, etc.)</p> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Provide plexiglass, face shields, and/or auxiliary aids for one-on-one close contact to ensure students with disabilities have equal access to information</li> <li>- Reference <a href="#">State Public Health Order</a> for face covering exceptions based on individual circumstances</li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Make accommodations for circumstances that encounter close contact (i.e., counseling, school psychologist)</li> </ul> |

| <p>Symptom Monitoring</p> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Establish a plan to assist families in conducting symptom checking at-home</li> <li>- Assist families in access to thermometers, or other items, as needed to fulfill appropriate symptom checking requirements</li> <li>- Monitor staff/student symptoms and absenteeism carefully</li> <li>- Educate and promote to staff/students: <b>if you feel sick; individuals experiencing symptoms should</b> stay at home</li> </ul> |

### Containing Potential Outbreaks

| <p>Preparation Phase</p>             | <p>State Required:</p> <ul style="list-style-type: none"> <li>- Develop Administrator/Teacher/Staff education and training on school’s protocol for containing potential outbreaks</li> <li>- Consult with local health department regarding procedures for tracing a positive COVID-19 case by an employee, student, visitor, or those who have come into contact with an individual testing positive</li> </ul>   |
| <p>Quarantine/Isolation Protocol</p> | <p>State Required:</p> <ul style="list-style-type: none"> <li>- Designate quarantine rooms at each school to temporarily house students who are unable to return home</li> <li>- Communicate health and safety issues transparently, while protecting the privacy of students and families</li> <li>- <u><a href="#">Implement proactive planning, protocols and procedures for outbreak scenarios as recommended in the Utah Department of Health’s COVID-19 School Manual</a></u></li> </ul> <p>Recommended:</p> <ul style="list-style-type: none"> <li>- Ensure office first aid kit includes a digital thermometer</li> <li>- Consider identifying three separate quarantine areas for students: a) a General Waiting Area (for students presenting with unscheduled needs); b) a Well Student Area (for students presenting with scheduled medical needs); c) a Quarantine Area (for students presenting with COVID-19 symptoms—separate from other students)</li> </ul> |

### Temporarily Reclosing (if Necessary)

| <b>Preparation Phase</b>                 | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Develop Administrator/Teacher/Staff education and training on school’s protocol for temporarily reclosing schools if necessary</li> <li>- Establish a plan in consultation with local health on responding to confirmed cases and the coordination of temporary closure of a school</li> <li>- In the event of an outbreak, contact the local health department in order to trigger the pre-established plan which may include: class dismissal, school dismissal, longevity of dismissal based on community spread, cleaning/sanitization, communications, contact tracing, etc.</li> </ul> |
| <b>Transition Management Preparation</b> | <p><b>State Required:</b></p> <ul style="list-style-type: none"> <li>- Develop a communication procedure for students and faculty in the case there is a temporary reclosure</li> <li>- Review original Continuity of Education Plans that were implemented during the spring 2020 soft closure and analyze lessons learned. Consider making changes accordingly and incorporating into transition management plans</li> <li>- Analyze remote learning capabilities</li> <li>- Explore extracurriculars/in-person events that may also need to be temporarily postponed/canceled or transitioned to virtual</li> </ul>  |
