


# **Emergency Preparedness and Emergency** Response Plan Follow-Up



# State Security Chief Pennington



**Chief Matt Pennington** has served as a police officer since 2004, beginning his career with the Weber County Sheriff's Office where he worked as a deputy sheriff in patrol until he left in 2007 to join the South Jordan Police Department. In January 2024, Chief Pennington was appointed as the first Utah State Security Chief by Commissioner Anderson with the Department of Public Safety, where he will be responsible for overseeing safety and security for schools and other infrastructure state-wide. Chief Pennington holds a Bachelor of Science Degree in Sociology with a certificate in Criminology and Corrections from the University of Utah, a Master's Degree in Management and Leadership and an MBA from Western Governors University.



### Guardian Program (1)

- Each public and charter school in the State of Utah must select one of the following options; or a combination of:
  - School Resource Officer
  - Armed Guardian
  - Armed School Security Guard
- The intent of the bill is to have coverage when school is in session.
- School Resource Officer: Sworn and certified law enforcement officer whose agency contracts with local education agencies for school-based law enforcement services.



### Guardian Program (2)

- Armed Guardian: A school employee who volunteers to be part of the program.
- Armed School Security Guard: employed by a contracted security company whose primary duty is to safeguard persons and property within the school and has immediate access to a firearm within the course of their duties.
- State Security Chief will keep database of Armed Security Guards and Armed Guardians.
- Dissemination of Armed Guardian identity may be punishable by a class B misdemeanor.

#### Guardian Program (3)

- Guardian training program will be selected by the State Security Chief.
  - County Security Chiefs will implement the program at the County level.
- Must have a Carrying Concealed Weapon (CCW) permit and pass a background check.
- Mental health screening to selected by State Security Chief in collaboration with OSUMH.
- County Security Chief has power to deny certification of Guardian.

- The State Security Chief in collaboration with the School Safety Center will establish rules to require an LEA to create emergency response plans. Plans shall include developmentally appropriate training for students and adults regarding:
  - Active threats
  - Emergency Preparedness
  - Drills
  - Standard Response Protocols (SRP)



#### Multidisciplinary Teams

- The School Safety Center, State Security Chief, and Office of Substance Use and Mental Health will develop model policies requiring behavioral threat assessment.
- The School Safety Center and State Security Chief will provide training in behavioral threat assessment best practices and improving school culture and climate.
- If a Local Education Agency (LEA) receives information from juvenile court that a student was arrested for a violent felony, multidisciplinary team shall develop a reintegration plan for the student.

- Substantial Threat: A threat made with serious intent to cause harm.
  - Threat exhibits a high risk of death or serious bodily injury.
- If a state employee or a person in a position of trust, the shall:
  - report the incident immediately to the State Security Chief;
  - the Local Education Agency (LEA) the threat would impact; or
  - the local law enforcement agency.
- If an LEA receives report must be relayed to local law enforcement and State Security Chief.



#### Reporting a Substantial Threat (2)

- If State Security Chief receives report must be relayed to LEA and local law enforcement.
- If law enforcement receives report must be relayed to State Security Chief and LEA.
  - LEA may request completed investigative report and law enforcement agency shall provide report.

# School Safety and Security Specialists (1)

- Each public and charter school is required to have a School Safety and Security Specialist.
  - Reports to the principal of the school.
  - Oversees safety and security practices to ensure safe and secure environment.
  - Conduct annual safety needs assessments and building needs assessments.
  - Participates on the multidisciplinary team.
  - Monitor for and report to the principal any safety and security concerns resulting from facilities issues or concerns with policies, procedures, and implementation relating to safety and security.



# School Safety and Security Specialists (2)

- Each public and charter school is required to have a School Safety and Security Specialist.
  - Implement and monitor safety and security drills.
  - Ensure compliance and training standards with students and staff relating to school's safety and security policies and procedures.
  - Organize debriefings after school's safety and security has been compromised.
  - Adhere to LEA, school, or law enforcement policy relating to chain of command.
  - Participate in annual training determined by the State Security Chief and the School Safety Center.

### Ongoing Funding

 School Safety and Security Specialist Program will be funded with ongoing funds made available through H.B. 61 (2023).



# H.B. 182 (2024)

#### **Student Survey Amendments**

Overview



#### 1. Parent Consent

- Type A Surveys: LEAs shall obtain parental consent annually in writing\* during registration for:
  - surveys related to early-warning systems (<u>53F-4-207</u>)
  - surveys with social-emotional learning questions
  - school climate survey (<u>53G-8-802</u>)
  - \*An electronic signature meets the "in writing" requirement.
- Type B Surveys: Parental consent for surveys not listed above must follow requirements stated in <u>53E-9-203</u>.

#### Reminder: Validity of Parental Consent

#### Parents must:

- first be given written notice
- be provided a copy of the survey questions in the written notice
- be given a reasonable opportunity to obtain written information about the survey

See <u>53E-9-203(5)(a)</u> for more details.

#### 2. Model School Climate Survey

- LEAs may opt-in for the administration of the model school climate survey created by the State Board of Education (<u>53G-8-802</u>).
  - If your LEA decides to administer the model school climate survey,
     USBE will still provide support.
- LEA school discipline policies are still required to be informed and updated by data obtained by any regular safety or health related survey, including a school's climate survey as described in Rule R277-623 (R277-609-2).

- LEAs must obtain new consent for a transferring student from a different LEA.
- **Prior consent** from the previous LEA is **not valid**, even during the same school year.

#### 4. Data Collection Information

LEAs must provide information about the data collection process, specifically:

- the survey to be administered
- the intended purposes and uses of the data collected;
- the types of persons or governmental entities that:
  - share the collected data, including a list of recipients who will receive student-level data; or
  - receive the data collected from a governmental entity on a regular or contractual basis; and
- the record series as defined in Section <u>63G-2-103</u> in which the data is or will be included, if applicable.\*



<sup>\*</sup>USBE is still seeking clarification.

#### 5. Survey Participation

• LEAs cannot provide a reward or consequence related to survey participation.

### Importance of Collecting & Analyzing Data

"Is being a safe school an objective or subjective measure?"

- Ongoing data collection is necessary to help inform safety decisions on the district and building level.
- LEA's may wish to include multiple and diverse data points; collected within the school and by community partners.
- Importance of both qualitative and quantitative data
- CSTAG / threat assessment is not affected.

  - b. research other safety data that is being collected at the community level (e.g., Local Mental Health Authority (LMHA), local health department, law enforcement agency, etc.).


