

## STATE AGENCY ADMINISTRATIVE REVIEW SUMMARY

The direct certification notification is missing school phone number and email contact information. Application(s) missing social security number (SSN) or indication of no SSN. Miscategorized application(s). Notification to Household of eligibility and denial of benefits not consistent with FNS requirements. SFA did not perform direct certification matches with the State agency according to required time frames. Benefits not accurately extended to students living in a household receiving SNAP, TANF, FDPIR, or Medicaid benefits. Incorrect sample size selected for verification. School's meal counts by category not used correctly in the SFA's claim for reimbursement.
