2 **R277-489. Kindergarten Programs and Assessment.**

3 **R277-489-1. Authority and Purpose.**

4 (1) This rule is authorized by:

5 (a) Utah Constitution Article X, Section 3, which vests general control and
6 supervision over public education in the Board;

7 (b) Subsection 53E-3-401(4), which permits the Board to make rules to execute
8 the Board's duties and responsibilities under the Utah constitution and state law; and

9 ~~[(c) Section 53F-2-507, which directs the Board to distribute funds appropriated
10 for OEK and FDK to LEAs that apply for the funds.]~~

11 (c) Section 53G-7-203, which requires the Board to establish rules regarding the
12 administration of and reporting regarding the kindergarten assessment.

13 (2) The purpose of this rule is to[:

14 ~~—(a) require LEAs to administer a kindergarten entry and exit assessment; and~~

15 ~~—(b) establish criteria and procedures to administer the optional enhanced
16 kindergarten program and full-day kindergarten.]designate the kindergarten assessment~~

17 and establish timelines and requirements for administration and reporting assessment
18 results and enrollment.

20 **R277-489-2. Definitions.**

21 ~~[(1) "Efforts to expand FDK statewide" means an LEA's readiness to expand to
22 additional FDK classrooms.]~~

23 ~~—(2) "FDK" or "full-day kindergarten" means a kindergarten day where the
24 schedule is equivalent in length to grades 1 through 3.~~

25 ~~—(3) "Geography" means the classification of the county in which the LEA is
26 located, with priority to counties in this order:~~

27 ~~—(a) sixth class county;~~

28 ~~—(b) fifth class county;~~

29 ~~—(c) fourth class county;~~

30 ~~_____ (d) third class county;~~
31 ~~_____ (e) second class county; and~~
32 ~~_____ (f) first class county.~~
33 ~~_____ (4) "LEA's receipt of ongoing federal funding" means the amount of ongoing Title~~
34 ~~I funding used by an LEA to fund FDK.~~

35 ~~_____ (5) "Optional enhanced kindergarten program" or "OEK" means a program that~~
36 ~~provides additional instruction to kindergarten age students.~~

37 ~~_____ (6) "Socioeconomic need" means an LEA's percentage of students eligible for~~
38 ~~free and reduced lunch, with priority to an LEA with a greater percentage of eligible~~
39 ~~students.]~~

40 ~~[(7)]~~ "Utah eTranscript and Record Exchange" or "UTREx" means a system that
41 allows individual detailed student records to be exchanged electronically between public
42 education LEAs and the Board, and allows electronic transcripts to be sent to any post-
43 secondary institution, private or public, in-state or out-of-state, that participates in the e-
44 transcript service.

46 **R277-489-3. Administration of Kindergarten Entry and Exit Assessments.**

47 (1) ~~[Except as provided in Subsection (2), an LEA shall administer:]~~ For purposes
48 of Subsection 53G-7-203(4), the Board selected kindergarten assessment is the
49 kindergarten entry and exit profile or KEEP, which includes the kindergarten entry and
50 exit assessments, required to be administered by LEAs as described in Section 53G-7-
51 203.

52 (2) An LEA shall administer:

53 (a) ~~[a]the~~ kindergarten entry assessment~~[, approved by the Superintendent,]~~ to
54 each kindergarten student sometime during the three weeks before through the three
55 weeks after the first day of kindergarten; and

56 (b) ~~[a]the~~ kindergarten exit assessment~~[, approved by the Superintendent,]~~ to
57 each kindergarten student sometime during the four weeks before the last day of
58 school.

59 [~~_____ (2) An LEA is not required to administer the kindergarten entry and exit~~
60 ~~assessments if the LEA does not participate in:~~
61 ~~_____ (a) the optional enhanced kindergarten program;~~
62 ~~_____ (b) full-day kindergarten; or~~
63 ~~_____ (c) the Early Interactive Reading Software Program described in Rule R277-~~
64 ~~496.]~~

65 (3) The days used for the assessment shall be consistent with Subsection R277-
66 419-~~[5]~~4(6)(d).

67 (4) An LEA shall submit to the Data Gateway:

68 (a) kindergarten entry assessment data by September 30; and

69 (b) kindergarten exit assessment data by June 15.

70 (5) In accordance with Section R277-114, the Superintendent may recommend
71 action to the Board, including withholding of funds, if an LEA fails to provide complete,
72 accurate, and timely reporting under Subsection (4).

74 **R277-489-4. Use of Kindergarten Entry and Exit Assessment Data.**

75 (1) The Superintendent or an LEA may use entry and exit assessment data
76 obtained in accordance with Section R277-489-3 to:

77 (a) provide insights into current levels of academic performance upon entry and
78 exit of kindergarten;

79 (b) identify students in need of early intervention instruction and promote
80 differentiated instruction for all students;

81 (c) understand the effectiveness of programs, such as ~~[extended]~~full-day
82 kindergarten and preschool;

83 (d) provide opportunities for data-informed decision making and cost-benefit
84 analysis of early learning initiatives;

85 (e) identify effective instructional practices or strategies for improving student
86 achievement outcomes in a targeted manner; and

87 (f) understand the influence and impact of full-day kindergarten on at-risk
88 students in both the short- and long-term.

89 (2) An LEA may not use entry and exit assessment data obtained in accordance
90 with Section R277-489-3 to:

91 (a) justify early enrollment of a student who is not currently eligible to enroll in
92 kindergarten, such as a student with a birthday falling after September 1;

93 (b) evaluate an educator's teaching performance; or

94 (c) determine whether a student should be retained or promoted between
95 grades.

97 **R277-489-5. Kindergarten Enrollment Reporting.**

98 (1) An LEA shall submit student membership information daily to the
99 Superintendent using the appropriate kindergarten code through UTREx.

100 (2) The Superintendent shall review October 1 and June 15 kindergarten
101 membership information annually to inform LEA funding allocations and to inform
102 potential Board action.
