22 ~~English language learner software under Section 53F-2-419 by adding:~~

23 ~~—— (a) the base amount available to the LEA in accordance with the LEA Base~~
24 ~~Allocation Table using the LEA's October 1 student count from the prior school year; and~~

25 ~~—— (b) a per student amount for each LEA calculated using the number of eligible~~
26 ~~students from the LEA's October 1 student count from the prior school year and the funds~~
27 ~~remaining from the legislative allocation after setting aside the amounts identified in~~
28 ~~Subsection (1)(a).~~

29 ~~—— (2) The Superintendent shall notify each LEA of the LEA's projected funding~~
30 ~~amount by July 1 annually.~~

31 ~~—— (3) An LEA shall submit an application to the Superintendent to notify the~~

33 ~~language learner software program.~~
