Legislative Block Grant Proposals

Associate Superintendent Patrick Ogden reviewed the Block Grant proposals being discussed by the Education Appropriations Committee. He indicated they are proposing three additional non-teaching days to be used at the discretion of the district for professional development. The estimated cost for this would be \$15 million. Mr. Ogden also reviewed the unresolved issues with regard to block granting. (For complete details of the material presented, see General Exhibit No. 8535.)

Discussion ensued relative to the implications of block granting and how it affects the allocation for wpu and the Board is priorities.

Motion was made by Member Linnea S. Barney and seconded by Member Mike

Anderson that the Board support the proposal being made by the Utah State Office of Education

and to emphasize to legislators the importance of maintaining ongoing funding for these programs. Motion carried with Members Anderson, Barney, Brown, Kennedy, Larson, Moss, Shields and Theurer voting in favor; Members McCain and Morrill absent.

Chairman Burningham encouraged Board Members to contact legislators on the appropriation is committee.

Utah State Office of Education Budget

Deputy Superintendent Gary Carlston reported that the Legislative Fiscal Analyst has proposed the base budget that currently exists for the Utah State Office of Education. At the last committee meeting their was a motion to approve that and it did not pass. The co-chair of the committee explained that there was some discussion that maybe before adopting a budget for the State Office of Education there could be some way of looking at different ways of delivering services -- possibly districts contracting with the state office. It is anticipated that this will be up for discussion tomorrow.

House Bill 34 - Applied Technology Education Governance. February 15, 2001 -15658-

Associate Superintendent Robert O. Brems presented background information relative to the status of House Bill 34. He noted that there have been meetings with the Governor and the Speaker of the House relative to this legislation. The Governor is not in favor of the legislation because he feels it creates a third board.

Mr. Brems summarized the 3 rd Substitute House Bill 34. (For complete details, see General Exhibit No. 8536.)

Discussion ensued relative to the perception that applied technology education is post secondary. It was noted that the high school applied technology education program is the highest education some students will receive.

Further discussion ensued relative to the fact that the State Board of Education made a concession in support of the Joint Applied Technology Education Council hoping it would be able to help provide an appropriate applied technology education program for students. It was also noted that the State Board of Regents have failed to take any stand on the proposed legislation. Board members felt betrayed with this new proposal feeling that they have put forth

a concerted effort and now it seems they are getting stabbed in the back.

Further discussion ensued relative to the reauthorization of the task force that studied this issue last year and the duties of that task force which assumes that the Legislature and Governor have concluded that applied technology education in Utah is post-secondary education.

Further that the task force shall determine if applied technology education in Utah should be governed by: (a) the State Board of Regents; or (b) a single board of education governing public education, higher education, and applied technology education. Another alternative that is not mentioned was an independent board such as JATEC. Obviously missing is that applied technology education be left with the State Board for Applied Technology Education.

Motion was made by Member Jill G. Kennedy and seconded by Member David L.

Moss that the State Board seek a sponsor for an amendment to the 3 rd Substitute House Bill 34.

The amendment would be to strike line 127 and 128 up to the word ½ the, ² add after (a) the State Board of Education; (b) State Board of Regents; (c) The single board of Education and (d) to include the language that was there before regarding JATEC. Motion carried with Members.February 15, 2001 -15659-

Anderson, Barney, Brown, Kennedy, Larson, McCain, Moss, Shields and Theurer voting in favor; Member Morrill absent.

Motion was made by Member Teresa L. Theurer and seconded by Member Laurel Brown that the Board is position relative to 3 rd Substitute HB 34 be opposed unless it is amended as identified by the previous motion. Motion carried with Members Anderson, Barney, Brown, Kennedy, Larson, McCain, Moss, Shields and Theurer voting in favor; Member Morrill absent.

House Bill 138 - Individual Income Tax and Corporate

Franchise and Income Tax Credits for Qualifying

Education Expenses

Chairman Burningham noted that there is proposed legislation H.B. 138 which deals with tuition tax credits. The Utah School Boards Association has a strong position in opposition to this legislation. The USBA has planned a press conference tomorrow at 12:00 Noon on the steps of the capitol to state their position of opposition to this legislation. They have invited

representatives of the PTA, the Utah School Superintendents Association and the Chair of the State Board to make a statement relative to this legislation.

Member Judy Larson commented that the USBA is opposed because they feel it is an erosion of public education.

Discussion ensued relative to the feeling that this would cause an erosion of the public education system which has been operating in this country and has been very successful.

Motion was made by Member Marilyn Shields and seconded by Member Judy Larson to strongly oppose HB 138, and anything else that would erode public education.

Discussion ensued relative to the possibility of this type of funding being provided through private foundations and donors to help build a system for less privileged students in providing scholarships. It was also felt that this is very inequitable.

Motion carried unanimously.

Chairman Burningham noted that he would represent the Board at the press conference tomorrow and indicate a strong opposition to this legislation and anything else that would erode public education.

Discussion ensued relative to whether this would benefit schools and activities and not create a dramatic impact on us. Also, the need to provide additional administrative efforts to figure the taxes.

Motion failed with Members Brown, Kennedy, Larson, McCain, Moss, and Shields voting against; Members Anderson, Barney and Morrill and Theurer voting in favor.

Motion was made by Member A. Earl McCain and seconded by Member Linnea S.

Barney to support HB 78. Motion carried with Members Anderson, Barney, Brown, Kennedy,

Larson, McCain, Moss, and Shields voting in favor; Members Morrill and Theurer opposed.

HB 99 - Reading Skills Development Center Amendments

Motion was made by Member Linnea S. Barney and seconded by Member Mike

Anderson to withdraw the position of support from HB 99.

Discussion ensued relative to public education money going to one institution for a

reading clinic. Also, that it appears to be research oriented.

Deputy Superintendent Gary Carlston recommended that the Board change its

position to ½ support concept, ² but the money should not come from public education

appropriations.

It was clarified that the Board is not opposed to a reading clinic, they are opposed to

the funding going to one institution.

Motion to change support to support concept carried unanimously.

HB 131 - Internet Child Protection Act

Motion was made by Member Teresa L. Theurer and seconded by Member Judy

Larson to support HB 131. Motion carried unanimously.

HB 142 - Addressing Physical Fitness and Nutrition in Public Education. February 15, 2001

Motion was made by Member Denis R. Morrill and seconded by Member Judy

Larson to oppose HB 142.

Discussion ensued relative to supporting the concept of physical fitness, but that it is

already addressed in the core curriculum.

Substitute motion was made by Member Teresa L. Theurer and seconded by Member

Mike Anderson that the Board is position be ½ unnecessary. 2

Substitute motion failed with Member Kennedy and Theurer voting in favor;

Members Anderson, Barney, Brown, Larson, McCain, Morrill, Moss, and Shields voting against.

Original motion carried with Members Anderson, Barney, Brown, Larson, McCain,

Morrill, Moss and Shields voting in favor; Members Kennedy and Theurer opposed.

HB 145 - Reading Achievement in Elementary Schools

Motion was made by Member Teresa L. Theurer and seconded by Member Linnea S.

Barney to oppose HB 145 because of the retention aspect. Motion carried unanimously.

HB 168 - Notice by School to Custodial and Noncustodial Parent

HB 189 - Federal Government Acquisition of Real Property in the State

relative to whether it would be feasible to request the Board of Regents take a formal position on HB 34. It was allegedly reported that the full Board of Regents had not been involved and made aware of this legislation, it was just being pushed by a few. It was noted that we are close to the end of the session and it may not be possible to get such a resolution.

Motion was made by Member Marilyn Shields and seconded by Member David L.

Moss that the State Board of Education request the Board of Regents to identify their position on this matter. Motion carried with Members Anderson, Barney, Brown, Kennedy, Larson,

McCain, Morrill, Moss and Shields voting in favor; Member Theurer absent.
