#### **Call to Order**

#### **Discussion with Senator Howard Stephenson**

Senator Stephenson was welcomed to the meeting. He distributed a handout concerning dual language immersion and indicated he would like to have further discussion on the program during the legislative interim session. He also requested that during the interim further discussion be held on test preparation for ACT and AP.

Senator Stephenson expressed appreciation to the Board's staff that has been working so hard on the Digital Teaching and Learning Program. He expressed concern about the fidelity of local education agencies (LEAs) with other technology programs. He distributed information about use of the math and early reading intervention program software, and questioned why districts not using these programs would implement a digital teaching and learning plan. He suggested reevaluating the program and consulting with national experts.

# **Review of Legislation**

Representative LaVar Christensen was welcomed to the meeting. He reviewed H.B. 264 *Utah Public Education Review and Strategic Planning* with the Board. He mentioned that the

Legislative Fiscal Auditor's office may be able to assist with the work required in the legislation.

# American Institutes of Research (AIR) Contract Settlement

Assistant Attorney General Michael Bell reviewed a proposed settlement with American Institutes for Research (AIR) on its contract for the Board's SAGE assessment system. AIR has offered to reduce the proposed extension to the contract by \$200,000. AAG Bell recommended that the Board accept the settlement offer of \$200,000 from AIR in full satisfaction and compromise of all claims and counter claims on the AIR SAGE contract to date [contract #136199].

**MOTION** was made by Member Lear and seconded by Member Belnap that the Board accept the settlement offer with American Institutes for Research as outlined.

Motion carried; Member Neilson absent.

# **Digital Teaching and Learning Overview**

Patty Norman, Assistant Superintendent, and Sarah Young, Digital Teaching and Learning Coordinator, gave an overview of the Digital Teaching and Learning Program and the process the Board followed to approve the local education agency plans.

#### **State Assessment and Accountability**

Deputy Superintendent Rich Nye reported that legislation with amendments to student assessment and school accountability will be heard by a legislative committee today. Tiffany Stanley, Policy Analyst, reviewed the assessment sections of S.B. 220, Student Assessment and School Accountability Amendments. A handout was distributed.

**MOTION** was made by Member B. Cummins and seconded by Member Lear that the Board support the adoption of a single, coherent accountability system that: 1) Includes multiple indicators focused on student-level outcomes; 2) uses an evidence-based process to establish criteria associated with overall school ratings; and 3) reports results in a clear transparent manner using a dashboard of indicators and other locally selected measures.

Motion carried; Member Neilson absent.
