# UTAH STATE BOARD OF EDUCATION <br> Audit Appeal Minutes 

June 29, 2021

## Opening Business

Chair Huntsman called the hearing to order at 2:02 p.m.

## American Preparatory Academy (APA) Audit Appeal

Dave Mortensen introduced his legal team Ted Heaps, Thomas Young, Brad Blanchard, Dee Henderson, Stephanie Henderson, and Joan Ottley-Zeeman. Dave Mortensen presented the APA argument that "The Board should review the questioned costs and determine the amount of funds, if any, APA will be required to reimburse the State of Utah in accordance with the provisions of the Agreement."
i. The presentation along with exhibits was presented to the board members.

## State Board of Education Presentation

Bryan Quesenberry, Assistant Attorney General presented a response to APA's request for the audit appeal and disputed APA's five appeal arguments.
i. Occupational Therapists who worked exclusively with special ed students
ii. Speech Pathologists who worked exclusively with special ed students
iii. Special Education Administrative expenses allowed under Program Code 1205
iv. 1:1 Aides who worked exclusively with special education students
v. Paraeducators who estimated they worked exclusively with special education students $37 \%$ of the time and primarily with special education students $63 \%$ of the time.

## Action on Appeal

Followed by the presentations the board members ask clarifying questions.

BOARD MOTION That the Board requires APA to pay the full amount with the deadlines established in the Settlement Agreement, of $\$ 2,785,917.59$ (the full amount of questioned expenditures referenced in the November 5, 2020, APA audit) of the questioned costs detailed in the audit report prepared by internal audit staff.

Motion made by Member Belnap and seconded by Member Lear.

MOTION TO AMEND Motion made by Member Earl and seconded by Member Moss to delete 2,785, 917.59 and replace with 1,190,015.29.

Motion failed with Members Cline, Earl, Hutchings, Moss in favor and Members Hansen, Strate, Boothe, Hart, Cannon, Belnap, and Huntsman opposed.

Motion carried with Members Norton, Lear, Hutchings, Hansen, Strate, Davis, Belnap, Cannon, and Huntsman in favor and Members Earl, Cline, Moss, Boothe, and Hart opposed.
