#### **Opening Business**

#### **Board Officer Elections Procedures**

#### Per Board Policy 2002: Board Officer Elections Procedures

The Board will vote to establish the number of vice chairs to be elected to serve on the Executive Committee.

#### <u>Utah Code 53E-3-201</u>

The state board shall elect from its members a chair, and at least one vice chair, but no more than three vice chairs every other year at a meeting held any time between November 15 and January 15.

**MOTION** was made by Member Earl and seconded by Member Kerry that the Board elects two vice chairs to serve on the executive committee.

#### **Board Chair**

## **First Vice Chair**

Members Hart and Kerry were interested in running for the first vice chair position.

The voting board members ranked the candidates according to the member's preference.

- Molly Hart received nine votes.
- Joseph Kerry received six votes.

Member Molly Hart was elected to the first vice chair position.

## **Second Vice Chair**

Members Wood, Earl, and Boggess shared an interest in running for the second vice chair position.

The voting board members ranked the candidates according to the member's preferences.

## **First Round**

- Jennie Earl received three votes.
- Christina Boggess received six votes.
- LeAnn Wood received six votes.

#### Second Round

- Christina Boggess received six votes.
- LeAnn Wood received nine votes.

Member LeAnn Wood was elected to the second vice chair position.
