R277-628, School Libraries (Amendment)

R277-628 is being amended due to the passage of HB 29 Sensitive Material Review Amendments from the 2024 Legislative Session. Changes include adding an oversight category designation, updating LEA policy requirements, and adding a reporting and compliance section to the rule.

[(1) For challenges before July 1, 2024, an LEA shall report to the Board a removal of the material based on the final objective sensitive material determination, of which the LEA has sufficient information to support the determination of whether the material previously removed meets the objective sensitive material criteria.]

For challenges prior to July 1, 2024, an LEA shall report to the Board a removal of the material based on an LEA's final determination, of which the LEA has sufficient information to support the removal using the objective sensitive material criteria.

(2) Following the notification of an objective sensitive material statewide removal, [astate board member] three or more board members may, within 30 days of notification, request that the material be placed on a Board agenda [in full board meeting] for a vote [of the Board] to overturn the state-wide removal requirement [application of the

requirement according to the agenda process as outlined in Board by-laws].

The motion passed unanimously.

(3) "School community parent" is a parent who has a student currently attending the school, or will have a student enrolled in the school within one year, where the challenged instructional material is being reviewed in accordance with Subsection 53G-10-103(4).

FY25 Charter Base Funding Distributions

MOTION was made by Member Earl and seconded by Member Boothe that the Board approve a set uniform base amount for charter schools with less than 2,000 students or \$115 per student, whichever is greater, and allocate \$200,560 to charters with more than 2,000 students for the FY25 Charter Base Funding Program. The uniform base amount will allocate the full appropriation for the program. These amounts will be one-time and for FY25 only.

The motion carried.

In favor: Members Boggess and Cline.

Opposed: Members Davis, Earl, Hymas, Kerry, Lear, Norton, Reale, Strate, Wood, and Moss

opposed. Member Hart abstained.

MOTION TO CALL PREVIOUS QUESTION was made by Member Davis and seconded by Member Strate.

The motion failed.

In favor: Members Davis, Hart, Hymas, Norton, Reale, Strate, Wood, and Moss.

Opposed: Members Boggess, Cline, Earl, Green, and Kerry.

Absent: Members Boothe and Lear.

MOTION TO AMEND was made by Member Boggess and seconded by Member Green that the Board amends the above motion to add \$300,000 to charters with more than 5000 students and [\$200,560] \$200,000 with charters with more than 2000 students.

That the Board approves:

- 1. allocate \$300,000 to charters with more than 5,000 students;
- 2. allocate \$200,000 to charters with more than 2,000 students for the FY25 Charter Base Funding Program; and
- 3. a set uniform base amount for charter schools with less than 2,000 students or \$115 per student, whichever is greater.

The uniform base amount described in #3 will allocate the remaining funding from appropriation for the program after the amounts distributed to larger charter schools. These amounts will be one-time and for FY25 only.
