**2025 General Session Legislative Preparation**Prioritization of Board Legislative Funding Requests

**MOTION** was made by Member Earl and seconded by Member Hart that the Board combine the audit staff funding request (#9) with USBE Critical FTE needs (#1) and leave as a combined request in current #1 list.
