- Parents have failed to notify the school of absence,
- No Home School Affidavit has been filed,
- No notice of unenrollment has been sent to the school, and
- Parents have failed to respond to communications from the school (e.g., email, phone, text, etc.)

And one of the following

There has been no request for student records, or

There is no record of the child being enrolled in any other Utah LEA.

In such cases, a referral shall be made to for a welfare check.
