Educator must complete all of the following requirements

- Complete the requirements for the Associate level endorsement. Date
- Choose one option for CTE knowledge and experience: Date
 - Complete the USBE CTE Orientation Canvas course.
 - Complete 3 full years of Utah CTE teaching experience.
 - Currently hold a professional CTE endorsement.

It is strongly encouraged that you choose the first option and complete the CTE Orientation course within your first year.
- Complete a CTSO DECA/FBLA training by completing one of the following options.
 - Option 1: Attend the new advisor training held in the fall each year. A substitute will be required. The date and time will be shared through the BFM listserv. Or
 - Option 2: Volunteer to be a Judge at a Region or State DECA/FBLA competition. Regions are held in the fall, and State is held in the Spring each year. Dates will be sent through the BFM listserv. A substitute will be required.Date
- Complete the Methods of Teaching Business course through a regionally accredited institution (SUU, USU, UVU) with a C grade or higher. Date
- Schedule an interview with the CTE Specialist in order to demonstrate to the satisfaction of the USBE's CTE Specialist that you have both the necessary knowledge and skills to effectively teach students all of the competencies outlined in the strands & standards for the courses authorized by this endorsement.
