The Utah State Board of Education's 2024 Bill Book Will Be Released Soon!

S.B. 164 Family Outreach Amendments: Allows a school to apply to create a Family Outreach Program and establishes a process for submitting an application and receiving LEA governing board approval for a program. Provides for oversight of the program by the LEA governing board; allows the LEA governing board to appoint and oversee a family outreach liaison; and provides for annual evaluation of the performance of a program liaison. An LEA governing board must approve or deny

an application for a family outreach plan within 30 days of receiving the request. No funding was allocated. Effective Date: May 1, 2024.
