**MODEL SCHOOL DISTRICT/CHARTER SCHOOL EXEMPTION CERTIFICATE
FOR HOME SCHOOL INSTRUCTION**

The following student(s) (by name) is (are) exempt from compulsory attendance:

The parent/guardian assumes sole responsibility for the education of the student(s), except to the extent the school-age minor is dual enrolled in a public school. The parent/guardian is solely responsible for the selection of instructional materials and textbooks, the time, place and method of instruction, and evaluating the home school instruction.

Upon the request of a parent, a local school board shall identify the knowledge, skills, and competencies a student is recommended to attain by grade level and subject area to assist the parent in achieving college and career readiness through home schooling.

The school district/charter school has no obligation to review a home schooled student's work or curriculum **for credit** though it may do so consistent with its policies. A home schooled student may or may not qualify for a high school diploma issued by the school district or any of its schools or a charter school, consistent with school district/charter school policies.

This exemption will remain in effect as long as the student(s) attends a home school and the school district/charter school where the affidavit was filed remains the student's district of residence. A local school board that excuses a school-age minor from attendance, **will annually** issue a certificate stating that the student(s) are excused from attendance for the specified school year.
