2 **R277-724. Criteria for Sponsors Recruiting Day Care Facilities in the Child and**
3 **Adult Care Food Program.**

4 **R277-724-1. Authority and Purpose.**

5 (1) This rule is authorized by:

6 (a) [Utah Constitution Article X, Section 3](#) which vests general control and
7 supervision of public education in the Board;

8 (b) Subsection [53E-3-401\(4\)](#), which allows the Board to adopt rules in accordance
9 with its responsibilities; and

10 (c) Subsection [53E-3-501\(3\)](#), which authorizes the Board to administer and
11 distribute funds made available through programs of the federal government.

12 (2) The purpose of this rule is to establish eligibility criteria for new sponsoring
13 organizations to recruit facilities for child care centers and day care homes in unserved
14 areas.

16 **R277-724-[4]2. Definitions.**

17 ~~[A.](1) "Child and Adult Care Food Program (CACFP)" means [the section of the~~
18 ~~USOE that administers]the program that:~~

19 ~~(a) facilitates~~ the initiation, maintenance, and expansion of non-profit food services
20 ~~[programs]~~ for children in non-residential centers and homes which provide child
21 ~~care[-];and [The definition also includes the administration of]~~

22 ~~(b) administers~~ food service programs for non-residential adult day care.

23 ~~[B.—"Board" means the Utah State Board of Education.]~~

24 ~~[C.](2)(a) "Child care center" means any public or private nonprofit organization, or~~
25 ~~any proprietary title XX center, licensed or approved to provide nonresidential child care~~
26 ~~services to enrolled children, primarily of preschool age.~~

27 ~~(b) A [C]child care center[s] may participate in the CACFP as independent centers~~
28 ~~or under the auspices of a sponsoring organization.~~

29 ~~[D.](3) "Day care home" means an organized nonresidential child care program for~~

30 children enrolled in a private home, licensed or approved as a family or group day care
31 home and under the auspices of a sponsoring organization.

32 [E.](4) "Facilities" means a sponsored center or a family day care home.

33 [F.](5) "Institution" means an organization with whom the [USOE]Board has an
34 agreement to accept final administrative and financial responsibility for CACFP operation.

35 [G.](6) "Recruited facilities" means potential daycare centers or homes that a
36 prospective sponsoring organization is seeking[s] to enroll in CACFP participation.

37 [H.](7) "Service area" means the geographic area from which a sponsoring
38 organization draws its client facilities.

39 [I.](8) "Sponsoring organization" means a public or nonprofit private organization
40 which is entirely responsible for the administration of the food program in:

41 ([1]a) one or more day care homes;

42 ([2]b) a child care center, outside-school-hours care center, or adult day care
43 center which is a legally distinct entity from the sponsoring organization;

44 ([3]c) two or more child care centers, outside-school-hours care centers, or adult
45 day care centers are part of the organization; or

46 ([4]d) any combination of child care centers, adult day care centers, day care
47 homes, and outside-school-hours care centers.

48 [J.](9) "State agency" means the state educational agency or any other State
49 agency that has been designated by the Governor or other appropriate executive or by the
50 legislative authority of the state, and has been approved by the Department to administer
51 the Program within the state.

52 [K. "USOE" means the Utah State Office of Education.]

63 **R277-724-3. Criteria for Sponsoring Organizations and Recruiting Facilities.**

64 ~~[The following criteria shall be met before a sponsor is approved:]~~

65 ~~[A.](1) [The]~~To be approved as a participant in the CACFP, a sponsoring
66 organization shall provide the following assurances to the Superintendent that the
67 sponsoring organization's recruited facilities:

68 (a) are not currently participating or were recently terminated for convenience by
69 another sponsoring organization due to being outside the sponsoring organization's
70 service area; ~~[and]~~

71 ~~[B.](b) [The recruited facilities] have not been terminated for cause[.];~~

72 (c) have no unresolved serious deficiency pending with another sponsoring
73 organization; and

74 (d) do not owe a refund to another sponsoring organization. ~~[; and]~~

75 ~~[C.](2) [The]~~Prior to approval, a sponsoring organization shall provide a state
76 agency certification[ies]that other sponsoring organizations are unable to accommodate
77 the [targeted]recruited facilities or the area(s) where the recruited facilities[if/they] are
78 located because:

79 ~~[(1)]a~~ other sponsoring organizations generate insufficient resources to properly
80 train and monitor facilities; or

81 ~~[(2)]b~~ supervising additional facilities would threaten a currently participating
82 sponsoring organization's viability, capability or accountability.

84 **R277-724-4. New and Renewing Institution Performance Standards.**

85 ~~[A.](1) [The]~~A new or renewing institution shall ensure to the Superintendent at the
86 time of approval or renewal that:

87 ~~[(1) — it is]~~(a) the institution is financially viable and program funds are spent and

88 accounted for consistent with the requirements of federal law and regulations;
89 ~~[(2) that management practices are in effect to ensure that]~~(b) the institution and
90 participating facilities operate in accordance with federal law and regulations; and
91 ~~[(3) it]~~(c) the institution has internal controls and other management systems in
92 effect ~~[to ensure fiscal accountability and to ensure that]~~allowing for fiscal accountability
93 and the CACFP to operate[s] in accordance with federal law and regulations.
94 ~~[B. The USOE Child Nutrition Program Section]~~(2) The Superintendent shall
95 regulate and ensure that these performance criteria are met consistent with federal law
96 and regulations.
