1. Courses are to be a minimum of three semester hours.
2. Courses are to be graduate level.
3. Courses are to be taken within ten (10) years of the date of this application. Classes older than ten years will not be accepted.
4. Courses taken online will be accepted if they are aligned to the requirements.
5. Professional Development courses (e.g. those offered by as NUCC, SUTEC, etc.) must be pre-approved by USBE and entered in CACTUS.

Instructions for Completing the Application

1. You must have the Reading Endorsement Level 1 to apply for the Reading Interventionist Endorsement. You may apply for both at the same time.
2. For university courses, attach original transcripts (internet transcripts are not acceptable), *with the courses highlighted*. In some cases, the university course name on the transcript is non-specific, e.g. "Special Topics in Education," or "Language Arts." If this issue occurs, submit either a syllabus from the course or a letter from the instructor or department verifying that the course meets the requirement. Electronic transcripts are acceptable only if sent directly from the college/university through a transcript clearinghouse to transcripts@schools.utah.gov. Please submit eTranscripts before you submit your endorsement application. **Please make a note on the application that your transcripts have been sent electronically to USBE.**
3. For professional development courses, attach a copy of the Cactus report, *with the courses highlighted*.
4. On the next page, indicate the courses you have completed that satisfy each of the requirements. If the course name and number are not an exact match to those listed on the left (the pre-approved courses) check "other," and record in the box on the right the course you wish to substitute.
