

1 **R277. Education, Administration.**

2 **R277-465. CPR in Schools.**

3 **R277-465-1. Authority and Purpose.**

4 (1) This rule is authorized by:

5 (a) Utah Constitution [Article X, Section 3](#), which vests general control and
6 supervision over public education in the Board;

7 (b) Subsection [53E-3-401\(4\)](#), which allows the Board to make rules to execute the
8 Board's duties and responsibilities under the Utah Constitution and state law; and

9 (c) Subsection [53G-10-408\(2\)](#), which requires the Board to make rules to develop
10 and implement cardiopulmonary resuscitation (CPR) training as part of the core
11 curriculum standards for instruction in health

12 (2) The purpose of this rule is to provide:

13 (a) the requirements for the teaching of CPR in the health standards; and

14 (b) the criteria and distribution method for CPR training grants.

16 **R277-465-2. Definitions.**

17 (1) "Cardiopulmonary resuscitation" or "CPR" means the same as the term is
18 defined in Subsection [53G-10-408\(1\)\(b\)](#).

19 (2) "Psychomotor skills" means the same as the term is defined Subsection [53G-](#)
20 [10-408\(1\)\(e\)](#).

21 (3) "Specific material" means any material used by an LEA to comply with the
22 [Health Education Core Standards related to CPR](#).

24 **R277-465-3. CPR Health Standards Requirements.**

25 (1) An LEA shall provide the CPR instruction consistent with the Health Education
26 Core Standards and as required in Subsection [53G-10-408\(5\)](#);

27 (a) using a certified CPR instructor;

28 (b) following a current Emergency Cardiovascular Care (ECC) guidelines for CPR;

29 and

30 (c) using cognitive and psychomotor skills training.

31 (2) An LEA shall provide the CPR instruction using the following ratios as closely

32 as possible:

33 (a) a student to instructor ratio of no greater than 15:1; and

34 (b) a mannequin to student ratio no greater than 1:6.

35 (3) An LEA shall provide the CPR instruction at least once to each student between
36 grades 9 through 12 except as provided for in Subsection 53G-10-408(7).

38 **R277-465-4. CPR Training Grant Program.**

39 (1) An LEA may apply to receive CPR training grant funds.

40 (2) If an LEA chooses to apply for grant funds the LEA shall submit the following
41 information as part of the LEA's application:

42 _____ (a) LEA name;

43 _____ (b) point of contact to oversee the use of the funds;

44 _____ (c) the number of students the LEA will provide training;

45 _____ (d) the total amount of requested funds; and

46 _____ (e) which of the allowable uses of funding as described in Subsection (4) of this
47 part the LEA plans to utilize.

48 (3) Except as provided for in Subsection (6), an LEA may not receive more than
49 \$6.00 per student as the LEA's total award under this grant program.

50 (4) An LEA may only use awarded funds for the following purposes:

51 (a) to contract with the local emergency management system for a certified
52 instructor;

53 (b) to certify an LEA employee as an instructor; or

54 (c) to contract with a third party or group who specializes in CPR and AED
55 instruction to provide the instruction.

56 (5) Subject to legislative appropriation, an LEA may also apply to receive funds to
57 replace or purchase specific materials or equipment for the CPR instruction.

58 (6) The Superintendent shall distribute the funds described in Subsection (5) to an
59 LEA in an amount proportionate to the LEA's number of students compared to the total
60 number of students of all LEAs applying for specific materials or equipment grant.

61 (7) The Superintendent may adjust the amount an LEA receives for a specific
62 materials or equipment grant if the LEA demonstrates greater need through:

- 63 (i) lack of sufficient number of necessary materials or equipment;
64 (ii) low quality or deteriorated materials or equipment; and
65 (iii) an extended period of time since the last update or purchase of materials or
66 equipment.
