Each requirement may be earned by taking approved university courses, having a master's degree in library science or instructional technology, with an emphasis on school library media, completing the Microcredential(s), or certification.

If Taking Utah-Based University Courses Approved by USBE:

1. Courses are to be graduate level.
2. Courses are to be taken within six (6) years of the date of this application.
3. University courses are reviewed and approved by agreement with USBE.
4. Applicants must earn a C or higher in the course(s) taken.
