

## Utah State Board of Education – Licensure Testing Update – July 2018

This document is intended to provide information to interested parties about upcoming changes to the required tests for Educator Licensure in Utah. Please share this information with all individuals at your institution who counsel licensure candidates as to the appropriate test for their program.

The following tests have been regenerated and have changed significantly enough that a new standard setting was required. The new tests will first be administered in **September 2018**. Utah has participated in a multi-state standard setting for each of these tests and has set a preliminary passing score for each test based on feedback by Utah educators in the areas. An individual that has taken and passed the previously approved test prior to **9/1/2018** may be recommended for the indicated licensure. If an individual takes the test after that date, they must take the new test.

**Effective immediately**, Utah will adopt the 5440 Middle School Science test as an option to receive the Middle Level Science endorsement. The 5435 General Science: Content Knowledge test will continue to be an option. The testing requirement for the Middle Level Science endorsement will be reevaluated once the 5440 regeneration is complete in the 2018-19 school year.

Universities will be informed of the final passing score as soon as possible. **Please note that both the 5001 tests and the 5039 were originally scheduled to be finalized in 2017-18, but were delayed.**

The following tests have been regenerated and have changed significantly enough that a new standard setting must take place. Utah is currently planning to participate in a multi-state standard setting for each of these tests. Preliminary qualifying scores for these tests will be announced as soon as possible. The first administration of these tests may vary, but will first be administered no earlier than **September 2019**. Candidates for these areas may be recommended with a passing score on either version of the test, but only the new version will be available to test takers after September 2019. **If you have personnel that may be interested in participating in one of the multi-state standard settings for these tests, please have them contact the USBE content area specialist or the USBE Educator Licensing Coordinator.**
