248 ~~\_\_\_\_\_ (b) has not received a high school diploma or a Utah High School Completion~~

250 ~~\_\_\_\_\_ (c) intends to graduate from a K-12 high school; and~~

251 ~~\_\_\_\_\_ (d) attends a CCRP meeting with his school counselor, school administrator or~~
