The Emergency Food Assistance Program (TEFAP) Eligibility Announced

SALT LAKE CITY –Utah State Board of Education, Child Nutrition Programs and Utah Food Bank today announced household size and income criteria used for determining eligibility for The Emergency Food Assistance Program (TEFAP).

What is TEFAP?

The Emergency Food Assistance Program (TEFAP) is a federal program that helps supplement the diets of low-income Americans by providing them with emergency food assistance at no cost. USDA provides 100% American-grown USDA Foods and administrative funds to states to operate TEFAP.

Household Eligibility Guidelines

The information provided by the household is confidential and will be used only for purposes of determining TEFAP eligibility. Households whose income is at or below 185% of the current year Federal Poverty Income Guidelines are eligible to receive donated foods for home consumption by self-declaration.

Household eligibility will be based on total household income not in excess of the State-established income levels. The Income Eligibility Guidelines (IEGs) are effective from July 1 through June 30 every year. The Income Eligibility Guidelines are also located online at <https://www.fns.usda.gov/school-meals/income-eligibility-guidelines>.

Automatic eligibility is given to clients who currently participate in one of the following programs:

- Supplemental Nutrition Assistance Program (SNAP);
- Medicaid;
- Receive Free or Reduced-Price School Meal benefits; or
- Have a child enrolled in the Federal Head Start Program.

Programa de Asistencia de Alimentos de Emergencia (TEFAP)

SALT LAKE CITY – El Departamento de Educación del Estado de Utah, los Programas de Nutrición Infantil y el Banco de Alimentos de Utah anunciaron hoy el tamaño del hogar y los criterios de ingresos utilizados para determinar los requisitos para calificar para el Programa de Asistencia de Alimentos de Emergencia (TEFAP).

¿Qué es TEFAP?

El Programa de Asistencia de Alimentos de Emergencia (TEFAP) es un programa federal que ayuda a complementar las dietas de los estadounidenses de bajos ingresos brindándoles asistencia alimentaria de emergencia sin costo alguno. El Departamento de Agricultura de los Estados Unidos (USDA) proporciona alimentos del USDA 100% cultivados en Estados Unidos y fondos administrativos a los estados para operar TEFAP.

Requisitos del hogar

La información proporcionada por el hogar es confidencial y se utilizará únicamente con el fin de determinar la elegibilidad para TEFAP. Los hogares cuyos ingresos son iguales o inferiores al 185% de las Pautas Federales de Ingresos de Pobreza del año en curso califican para recibir alimentos donados para consumo doméstico mediante auto declaración.

La elegibilidad del hogar se basará en el ingreso total del hogar que no exceda los niveles de ingresos establecidos por el estado. Las Pautas de Elegibilidad de Ingresos (IEG) entran en vigencia desde el 1 de julio hasta el 30 de junio de cada año. Las Pautas de Elegibilidad de Ingresos también se encuentran en línea en <https://www.fns.usda.gov/school-meals/income-eligibility-guidelines>.

La elegibilidad automática se otorga a los clientes que actualmente participan en uno de los siguientes programas:

- Programa de Asistencia Nutricional Suplementaria (SNAP);
- Medicaid;

- Reciben beneficios de almuerzos escolares gratuitos o a precio reducido; o
- Tienen un niño inscrito en el Programa Federal Head Start.
