

1 **R277. Education, Administration.**

2 **R277-723. Start Smart Utah Program.**

3 **R277-723-1. Authority and Purpose.**

4 (1) This rule is authorized by:

5 (a) Utah Constitution Article X, Section 3, which vests general control and
6 supervision over public education in the Board;

7 (b) Section 53E-3-401(4), which allows the Board to make rules to execute the
8 Board's duties and responsibilities under the Utah Constitution and state law; and

9 (c) Section 53G-9-205.1 which directs the Board to create a waiver application,
10 submission, review, and approval process.

11 (2) The purpose of this rule is to provide the process to apply for and receive a
12 waiver from the requirements of 53G-9-205.1.

14 **R277-723-2. Definitions.**

15 (1) “Alternative breakfast service model” means the same as the term is defined
16 in 53G-9-205.1.

17 (2) “Financial hardship” means a school cannot maintain a positive financial
18 balance in the School food service account due to the operation of an alternative
19 breakfast service model or school breakfast program.

20 (3) “Logistical hardship” means a school lacks any capacity or resources to
21 perform the required duties and work flow to support an alternative breakfast service
22 model or school breakfast program.

23 (4) “Nonprofit school food service account” means the same as the term is
24 defined in 7 CFR 210.12

26 **R277-723-3. Procedures for Waiver Requests.**

27 (1)(a) An LEA board may request a waiver from some or all of the requirements
28 of 53G-9-205.1 by filing a written request.

29 (b) A written request under Subsection (1)(a) shall include:

- 30 (i) verification that the LEA board voted to request the waiver in an open
31 meeting;
- 32 (ii) the portions of Section 53G-9-205.1 for which the LEA is seeking a waiver;
33 (iii) documentation demonstrating the logistical or financial hardship resulting in
34 the need for a waiver including:
- 35 (A) cost benefit analysis showing reimbursement will not fully cover anticipated
36 costs;
- 37 (B) facility capacity unable to support food service needs; or
38 (C) other data demonstrating logistical or financial hardship;
- 39 (iv) evidence that the LEA has maintained the required three month balance in
40 the LEA's Nonprofit school food service account pursuant to 7 CFR 210.12.
- 41 (v) possible solutions to mitigate the future need for a waiver; and
42 (vi) alternative practices to ensure the LEA's free and reduced lunch student
43 population has the most access possible to food during regular school hours.
- 44 (2) An LEA shall submit a separate waiver for each school within the LEA that
45 the LEA seeks to exempt from the requirements of Section 53G-9-205.1.
- 46 (3) An LEA that satisfies the requirements of Subsection 53G-9-205.1(2)(d)(ii) is
47 exempt from needing to apply for a waiver.
- 48 (4) The Superintendent shall establish a review committee that consists of three
49 or members from relevant staff.
- 50 (5) The review committee shall review a waiver request for approval or denial
51 within 30 days of receipt of the waiver request.
- 52 (6) If the review committee denies an LEA's waiver request, an LEA may appeal
53 to the Board in writing within 10 calendar days of notice of denial.
- 54 (7) A waiver granted under R277-723 expires at the end of the school year for
55 which the waiver was granted.
- 56 (8) An LEA may create an implementation plan as part of the LEA's efforts to
57 mitigate the need for a future waiver.
- 58 (9) The Superintendent may provide additional supports and resources to an

59 LEA for the purposes of creating an implementation plan.

60 (10) An LEA may implement alternative breakfast service models before the
61 LEA's waiver has expired.

63 **R277-723-4. Corrective Action Plan**

64 (1) If an LEA is found to be non-compliant with Section 53G-9-205.1 and has
65 not applied for a waiver pursuant to R277-723, the LEA may be placed on a corrective
66 action plan described in R277-114.
