2 **R277-122. Board of Education Procurement.**

3 **R277-122-1. Authority and Purpose.**

4 (1) This rule is authorized by:

5 (a) Utah Constitution [Article X, Section 3](#), which vests general control and
6 supervision over public education in the Board;

7 (b) Section [53E-3-401\(4\)](#), which allows the Board to make rules to execute the
8 Board's duties and responsibilities under the Utah Constitution and state law; and

9 (c) [Title 63G, Chapter 6a](#), Utah Procurement Code.

10 (2) The purpose of this rule is to adopt and incorporate by reference [Title R33,](#)
11 [Purchasing and General Services](#), with exceptions as described in this rule.

13 **R277-122-2. Definitions.**

14 (1) "Professional service provider" means a provider of a professional service as
15 defined in ~~[Subs]~~ Section [63G-6a-103](#)~~[(64)]~~ and includes an expert in educational
16 instruction and teaching.

17 (2) "Responsible" means the same as that term is defined in ~~[Subs]~~ Section [63G-](#)
18 [6a-103](#) ~~[(75)]~~.

19 (3) "Responsive" means the same as that term is defined in ~~[Subs]~~ Section [63G-](#)
20 [6a-103](#) ~~[(76)]~~.

21 ~~[(4) "Unsolicited proposal" means the same as that term is defined in Subsection-~~
22 ~~63G-6a-712(1).]~~

24 **R277-122-3. Incorporation of Title R33 With Exceptions.**

25 (1) The Board adopts and incorporates by reference [Title R33, Purchasing and](#)
26 [General Services](#), as in effect on April 1, 20~~17~~22 , with the exceptions described in this
27 section.

28 (2) The Board does not adopt Section [R33-8-101b](#).

29 (3) The Board adopts Section R277-122-5 in place of Sections [R33-5-104](#) and
30 [R33-5-107](#).

31 (4) The Board adopts Section R277-122-6 in place of Section [R33-5-108](#).

41 **R277-122-4. Head of the Procurement Unit Designated.**

42 The Board designates the Board's Director of Purchasing as the head of the
43 procurement unit.

44

45 **R277-122-5. Small Purchases of Procurement Items Other than Professional** 46 **Services and Consultants.**

47 (1) The head of the procurement unit shall make small purchases in accordance
48 with the requirements set forth in Section [63G-6a-506](#) and this Section R277-122-~~[10]~~8.

49 (2) Unless otherwise required as part of another standard procurement process
50 being used in conjunction with a small purchase, the head of the procurement unit need
51 not utilize a solicitation or provide public notice to conduct a small purchase.

52 (3) The head of the procurement unit may make a small purchase of a
53 procurement item other than a professional service by:

54 (a) direct award without seeking competitive bids or quotes up to the following
55 threshold amounts:

56 (i) \$10,000 for one or more procurement items purchased at the same time from
57 one source; and

58 (ii) \$75,000 for multiple procurement items purchased in a 12-month period from
59 one source; and

60 (b) subject to Rule [R33-4-109](#), obtaining quotes from a minimum of two vendors
61 and purchasing the procurement item from the responsible vendor offering the lowest
62 quote for a purchase of up to [~~\$75,000~~] \$100,000 for one or more procurement items
63 purchased at the same time from a single source.

64 (4) When conducting a purchase under Subsection (3)(b) in conjunction with an
65 approved vendor list, the head of the procurement unit:

66 (a)(i) may obtain quotes from all the vendors on the approved vendor list; or

67 (ii) may obtain quotes from a minimum of two vendors on the approved vendor
68 list, using one or more of the following methods to select vendors from whom to obtain
69 quotes:

70 (A) a rotation system, organized alphabetically, numerically, or randomly;

71 (B) the geographic area serviced by each vendor;

72 (C) each vendor's particular expertise or field;

73 (D) solicitation of an additional quote from the vendor that provided the lowest
74 quote on the most recently completed procurement conducted by the Board using the
75 approved vendor list; or

76 (E) another method approved by the head of the procurement unit;

77 (b) shall document that all vendors on the approved vendor list have a fair and
78 equitable opportunity to obtain a contract; and

79 (c) shall purchase the procurement item from the responsible vendor on the
80 approved list offering the lowest quote.

81 (5) Whenever practicable, the head of the procurement unit shall use a rotation
82 system or other system designed to allow for competition when using a small purchase
83 process.

84 (6) In the process of obtaining a competitive quote, the head of the procurement
85 unit shall record and maintain the following as a government record:

86 (a) the names of the vendors from whom quotes were requested and received;

87 and

88 (b) the date of receipt and amount of each quote.

89 (7) The head of the procurement unit shall comply with all applicable laws and
90 rules in the conduct of small purchases, including:

91 (a) Subsection [63G-6a-506\(8\)](#);

92 (b) Title 63G, Chapter 6a, Part 24, Unlawful Conduct and Penalties; and

93 (c) Sections [R33-24-104](#) through [R33-24-106](#).

94

95 **R277-122-6. Small Purchases of Professional Service Providers and Consultants.**

96 (1) The head of the procurement unit shall make small purchases of professional
97 services in accordance with the requirements set forth in Section [63G-6a-506](#) and this
98 Section R277-122-11.

99 (2) Unless otherwise specifically required in this rule or as part of another
100 standard procurement process being used in conjunction with a small purchase, the
101 head of the procurement unit need not utilize a solicitation or provide public notice to
102 conduct a small purchase of professional services.

103 (3) The head of the procurement unit may procure professional services:

104 (a) up to a maximum of \$10,000 by direct negotiation with any professional
105 services provider or consultant determined in writing by the head of the procurement
106 unit to be qualified to provide the professional service; and

107 (b) up to a maximum of [~~\$100,000~~] \$175,000 by:

108 (i) subject to Rule [R33-4-109](#), obtaining quotes from a minimum of three
109 professional services providers or consultants determined in writing by the head of the
110 procurement unit to be qualified to provide the professional services; and

111 (ii) making the purchase from the professional service provider or consultant
112 determined in writing by the head of the procurement unit to provide the Board with the
113 best value, comparing qualifications and price.

114 (4) The head of the procurement unit may utilize the process set forth in
115 Subsection (3)(b) to make purchases from multiple professional service providers or
116 consultants if:

117 (a) multiple professional service providers or consultants of the same type are
118 required to fulfill the need for the professional service;

119 (b) the total amount awarded to the selected professional service providers or
120 consultants does not exceed \$250,000;

121 (c) a request for qualifications and quotes is published in accordance with
122 Section [63G-6a-112](#);

123 (d) the request for qualifications and quotes states that the Board may make a
124 purchase from multiple professional service providers or consultants; and

125 (e) all responses received are reviewed and considered when selecting the best
126 value professional service providers or consultants.

127 (5) The head of the procurement unit shall comply with all applicable laws and
128 rules in the conduct of small purchases for professional services, including:

129 (a) Subsection [63G-6a-506\(8\)](#);

130 (b) [Title 63G, Chapter 6a, Part 24](#), Unlawful Conduct and Penalties; and

131 (c) Sections [R33-24-104](#) through [R33-24-106](#).

134 ~~**the Request for Proposal Process.**~~

135 ~~——(1) The head of the procurement unit shall score proposals against evaluation~~
136 ~~criteria other than cost in the request for proposal process to:~~

137 ~~——(a) determine which proposals meet mandatory minimum requirements or~~
138 ~~minimum score thresholds set forth in a request for proposal; and~~

139 ~~——(b) assist the head of the procurement unit in selecting the proposal that provides~~
140 ~~the best value or is the most advantageous to the Board.~~

141 ~~——(2) The head of the procurement unit shall award points for each applicable~~
142 ~~evaluation criteria set forth in a request for proposal.~~

143 ~~—— (3) The head of the procurement unit shall evaluate request for proposals based-~~
144 ~~on a ten-point scale consisting of all whole numbers from zero to ten, with scores-~~
145 ~~adhering to the following benchmarks:~~

146 ~~—— (a) Ten points: the proposed solution measurably exceeds requirements and-~~
147 ~~expectations as described in the request for proposal;~~

148 ~~—— (b) Five points: the proposed solution satisfactorily meets requirements and-~~
149 ~~expectations as described in the request for proposal; and~~

150 ~~—— (c) Zero points: the proposed solution does not meet requirements and-~~
151 ~~expectations as described in the request for proposal.~~

152 ~~—— (4) The head of the procurement unit may use an alternative scoring scale if-~~

155 **~~R277-122-8. Multiple Category Request for Proposals Process Resulting in a~~**
156 **~~Single Award.~~**

157 ~~—— (1) In accordance with Section 63G-6a-710, the head of the procurement unit-~~
158 ~~may conduct a multiple stage process as a multiple category request for proposals-~~
159 ~~process resulting in a single contract award.~~

160 ~~—— (2) The head of the procurement unit may use a multiple category request for-~~
161 ~~proposals process when proposals are accepted in more than one category of solution,~~
162 ~~and the category of solution providing the best value to the Board is not determined until~~
163 ~~the final stage of the multiple stage process.~~

164 ~~—— (3) When conducting a multiple category request for proposals process, the head-~~
165 ~~of the procurement unit shall:~~

166 ~~—— (a) comply with all requirements set forth in Title 63G, Chapter 6a, Part 7,~~
167 ~~Requests for Proposals;~~

168 ~~—— (b) allow offerors to submit proposals in more than one category; and~~

169 ~~—— (c) include in the request for proposals:~~

185 **R277-122-[9]7. Cancellation Before Award.**

186 (1) A solicitation may be cancelled prior to a contract award if:
187 (a) the Board does not receive any responsive responses to the solicitation; or
188 (b) the head of the procurement unit determines the cancellation is:
189 (i) in the best interest of the Board; and
190 (ii) supported by a reasonable and good faith justification.
191 (2) The head of the procurement unit shall include notice of the Board's right of
192 cancellation described in Subsection (1) in each Board solicitation.
193 (3) A solicitation may be re-issued:
194 (a) with or without modification, if cancelled pursuant to Subsection (1)(a); or
195 (b) with modification, if cancelled pursuant to Subsection (1)(b).

198 The head of the procurement unit shall develop standard terms and conditions
199 for use with Board contracts and agreements.

205 ~~—— (a) factual and verifiable information related to the contractor's estimated cost for-~~

235 Board contracts are reasonable, allocable, and allowable.
