3 ~~R277-713-1. Authority and Purpose.~~

4 ~~—— (1) This rule is authorized by:~~

5 ~~—— (a) Utah Constitution Article X, Section 3, which vests general control and~~  
6 ~~supervision over public education in the Board;~~

7 ~~—— (b) Subsection 53E-3-401(4), which allows the Board to make rules to execute the~~  
8 ~~Board's duties and responsibilities under the Utah Constitution and state law; and~~

9 ~~—— (c) Section 53F-2-409, which directs the Board to provide for the distribution of~~  
10 ~~concurrent enrollment dollars in rule.~~

11 ~~—— (2) The purpose of the concurrent enrollment program is to provide a challenging~~  
12 ~~college-level and productive experience to eligible students, and to provide transition~~  
13 ~~courses that can be applied to postsecondary education.~~

14 ~~—— (3) The purpose of this rule is to specify the standards and procedures for~~  
15 ~~concurrent enrollment courses and the criteria for funding appropriate concurrent~~  
16 ~~enrollment expenditures.~~

17 ~~R277-713-2. Definitions.~~

18 ~~—— (1) "Concurrent enrollment" means a public high school student is enrolled in a~~  
19 ~~course that satisfies both high school graduation requirements and qualifies for higher~~  
20 ~~education credit at a USHE institution.~~

21 ~~—— (2) "Concurrent enrollment program" or "program" means the program created in~~  
22 ~~Section 53E-10-302 that receives funding in accordance with Section 53F-2-409, which~~  
23 ~~allows students to participate in concurrent enrollment courses.~~

24 ~~—— (3) "Master course list" means a list of approved courses, maintained by the~~  
25 ~~Superintendent and USHE, which may be offered and funded through the concurrent~~  
26 ~~enrollment program.~~

27 ~~—— (4) "USHE" means the Utah System of Higher Education as described in Section~~  
28 ~~53B-1-102.~~

29 ~~**R277-713-3. Student Eligibility and Participation.**~~

30 ~~—— (1) A student participating in the program shall:~~

31 ~~—— (a) be an “eligible student” as described in Subsection 53E-10-301(5); and~~

32 ~~—— (b) have completed a concurrent enrollment participation form, including a parent~~  
33 ~~permission form and acknowledgment of program participation requirements, as required~~  
34 ~~in section 53E-10-304.~~

35 ~~—— (2) Student eligibility requirements for the program shall be:~~

36 ~~—— (a) established by an LEA and a USHE institution; and~~

37 ~~—— (b) sufficiently selective to predict a successful experience for qualified students.~~

38 ~~—— (3) An LEA has the primary responsibility for identifying a student who is eligible to~~  
39 ~~participate in a concurrent enrollment class.~~

40 ~~—— (4) To ensure that a student is prepared for college level work, an LEA shall~~  
41 ~~appropriately evaluate the student’s abilities prior to participation in concurrent enrollment~~  
42 ~~courses, and to determine that the student meets prerequisites previously established for~~  
43 ~~the same campus-based course by the sponsoring USHE institution.~~

44 ~~**R277-713-4. Course Credit and Offerings – Course Approval Process.**~~

45 ~~—— (1) Credit earned through a concurrent enrollment course:~~

46 ~~—— (a) has the same credit hour value as when taught on a college campus;~~

47 ~~—— (b) applies toward graduation on the same basis as a course taught at a USHE~~  
48 ~~institution to which the credits are submitted;~~

49 ~~—— (c) generates higher education credit that becomes a part of a student’s permanent~~  
50 ~~college transcript;~~

51 ~~—— (d) generates high school credit that is consistent with the LEA policies for awarding~~  
52 ~~credit for graduation; and~~

53 ~~—— (e) is transferable from one USHE institution to another.~~

54 ~~—— (2) A USHE institution is responsible to determine the credit for a concurrent~~  
55 ~~enrollment course, consistent with State Board of Regents’ policies.~~

56 ~~—— (3) An LEA and a USHE institution shall provide the Superintendent and USHE with~~  
57 ~~proposed new course offerings, including syllabi and curriculum materials, by November~~

58 ~~15 of the year preceding the school year in which the courses would be offered.~~

59 ~~——(4) A concurrent enrollment course shall be approved by the Superintendent and~~  
60 ~~USHE, and designated on the master course list, maintained by the Superintendent and~~  
61 ~~USHE.~~

62 ~~——(5)(a) Concurrent enrollment course offerings shall reflect the strengths and~~  
63 ~~resources of the respective schools and USHE institutions and be based upon student~~  
64 ~~needs.~~

65 ~~——(b) The number of courses selected shall be kept small enough to ensure~~  
66 ~~coordinated statewide development and professional development activities for~~  
67 ~~participating teachers.~~

68 ~~——(6) To provide for the focus of energy and resources on quality instruction in the~~  
69 ~~concurrent enrollment program, program courses shall be limited to courses in:~~

78 ~~——(7) A Technology-intensive concurrent enrollment (TICE) course is a hybrid course,~~  
79 ~~having a blend of different learning activities, available both in the classroom and online,~~  
80 ~~or may be delivered exclusively online.~~

81 ~~——(8) A concurrent enrollment course shall be a course at the 1000 or 2000 level in~~  
82 ~~postsecondary education, except for a 3000-level accelerated foreign language course,~~  
83 ~~which may be approved as a concurrent enrollment course for eligible students.~~

84 ~~——(9) A course may not be approved as a concurrent enrollment course if the course~~  
85 ~~is:~~

86 ~~——(a) a high school course that is typically offered in grade 9 or 10; or~~

87 ~~——(b) a postsecondary course below the 1000 level.~~

- 88 ~~—— (10) The appropriate USHE institution shall take responsibility for:~~

94 ~~—— (11) Concurrent enrollment procedures and materials shall be:~~

- 99 ~~—— (1)(a) Concurrent enrollment courses and curriculum may be provided through live~~  
100 ~~classroom instruction or by other means, including electronic communications. ——~~  
101 ~~—— (b) An LEA and a USHE institution shall design and implement courses to take full~~  
102 ~~advantage of the most currently available educational technology.~~  
103 ~~—— (2) An LEA shall use a Superintendent-designated 11-digit course code for a~~  
104 ~~concurrent enrollment course.~~  
105 ~~—— (3) An LEA and a USHE institution shall jointly align information technology systems~~  
106 ~~with all individual student academic achievement data so that student information will be~~  
107 ~~tracked through both education systems consistent with Section 53E-4-308.~~

108 **~~R277-713-6. Faculty and Educator Requirements.~~**

- 109 ~~—— (1) An educator who is not employed by a USHE institution and teaches a~~  
110 ~~concurrent enrollment course shall:~~  
111 ~~—— (a) be employed by an LEA; and~~  
112 ~~—— (b) meet the requirements of Subsections 53E-10-302(5) and (6).~~  
113 ~~—— (2) An educator employed by an LEA who teaches a concurrent enrollment course~~  
114 ~~shall be approved as an adjunct faculty member at the contracting USHE institution prior~~  
115 ~~to teaching the concurrent enrollment course.~~

116 ~~———(3) High school educators who hold adjunct or part time faculty status with a USHE~~  
117 ~~institution for the purpose of teaching concurrent enrollment courses shall be included as~~  
118 ~~fully as possible in the academic life of the supervising academic department at the USHE~~

120 ~~———(4) An LEA and a USHE institution shall share expertise and professional~~  
121 ~~development, as necessary, to adequately prepare a teacher to teach in the concurrent~~

128 ~~**Funds.**~~

129 ~~———(1) Program funds shall be allocated in accordance with Section 53F-2-409.~~

130 ~~———(2) Program funds allocated to LEAs may not be used for any other program or~~  
131 ~~purpose, except as provided in Section 53F-2-206.~~

132 ~~———(3) Concurrent enrollment funding may not be used to fund a parent- or~~  
133 ~~student-initiated college-level course at an institution of higher education.~~

134 ~~———(4) The Superintendent may not distribute concurrent enrollment funds to an LEA~~  
135 ~~for reimbursement of a concurrent enrollment course:~~

136 ~~———(a) that is not on the master course list;~~

137 ~~———(b) for a student that has exceeded 30 semester hours of concurrent enrollment for~~  
138 ~~the school year;~~

150 ~~——(6) An LEA's use of state funds for concurrent enrollment is limited to the following:~~

151 ~~——(a) aid in professional development of adjunct faculty in cooperation with the~~  
152 ~~participating USHE institution;~~

153 ~~——(b) assistance with delivery costs for distance learning programs;~~

154 ~~——(c) participation in the costs of LEA personnel who work with the program;~~

155 ~~——(d) student textbooks and other instructional materials;~~

156 ~~——(e) fee waivers for costs or expenses related to concurrent enrollment for fee-waiver~~  
157 ~~eligible students under R277-407;~~

158 ~~——(f) purchases by LEAs of classroom equipment required to conduct concurrent~~

168 **~~R277-713-8. Student Tuition and Fees.~~**

169 ~~——(1) A concurrent enrollment program student may be charged partial tuition and~~  
170 ~~program-related fees, in accordance with Section 53E-10-305.~~

171 ~~——(2) Postsecondary tuition and participation fees charged to a concurrent enrollment~~  
172 ~~student are not fees, as defined in R277-407, and do not qualify for a fee waiver under~~  
173 ~~R277-407.~~

174 ~~———(3)(a) All costs related to concurrent enrollment classes that are not tuition and~~  
175 ~~participation fees are subject to a fee waiver consistent with R277-407.~~

176 ~~———(b) Concurrent enrollment costs subject to fee waiver may include consumables, lab~~  
177 ~~fees, copying, material costs, and textbooks required for the course.~~

178 ~~———(4) (a) Except as provided in Subsection (4)(b), an LEA shall be responsible for fee~~  
179 ~~waivers.~~

180 ~~———(b) An agreement between a USHE institution and an LEA may address the~~  
181 ~~responsibility for fee waivers.~~

182 **~~R277-713-9. Annual Contracts and Other Student Instruction Issues.~~**

183 ~~———(1) An LEA and a USHE institution that plan to collaborate to offer a concurrent~~  
184 ~~enrollment course shall enter into an annual contract for the upcoming school year by no~~  
185 ~~later than May 30.~~

186 ~~———(2) An LEA shall provide the Superintendent a copy of each annual contract~~  
187 ~~entered into between the LEA and a USHE institution for the upcoming school year by no~~  
188 ~~later than May 30.~~

189 ~~———(3) An LEA and a USHE institution shall use the standard contract language~~  
190 ~~developed by the Superintendent and USHE.~~
