Each requirement may be earned by taking university courses, USBE courses, earning a master's degree in gifted education, passing the PRAXIS exam, planning and engaging in activities that foster professional growth, or other experiences that demonstrates knowledge, skills, and dispositions as approved by the USBE GIFTED AND TALENTED SPECIALIST. Examples of other experiences must be approved by attaching the Evidence of Competencies for the Gifted and Talented Endorsement Form.

If Taking Utah-Based University Courses Approved by USBE:

1. Courses are to be taken within eight (8) years of the date of this application.
2. University courses must follow the [USBE course frameworks](#).
3. Applicants must earn a C or higher in the course(s) taken.
