## CACTUS/USIMS updates

- It is no longer required to record student teachers in CACTUS/USIMS.
- SHiNE amounts may be updated prior to termination in CACTUS. SHiNE is not available in USIMS at this time.

## CACTUS/USIMS Transition Timeline

- Soft Release of USIMS is tentatively scheduled for the 3rd week of January with Statewide Release and CACTUS RDS sunset a few weeks after the testing period. We will *notify you prior* to the CACTUS RDS sunset.

## USBE will have access to CACTUS after the RDS is turned off.
