# Utah State Board of Education Approved Instructional Materials for Child Sexual Abuse and Human Trafficking Prevention

Updated September 2025

## Overview

Per [Utah Code Section 53G-9-207](#), every 3 years Local Education Agencies (LEAs) shall provide training and instruction on child sexual abuse and human trafficking prevention and awareness to school personnel in elementary and secondary schools as well as parents of elementary school students. LEAs may provide Child Sexual Abuse (CSA)/Human Trafficking (HT) instruction to elementary school students using an age-appropriate curriculum.

## Instructional materials:

- must be approved by USBE
- are approved for a 3-year period. After which, they must be resubmitted for approval
- must meet [minimum standards](#) (approved August 7, 2025)
- are intended for either adults serving youth, parent/guardian, or elementary students on the topics of child sexual abuse and/or
