FY25 – Juvenile Gang and other Violent Crime Prevention and Intervention Fund

HB362 - Juvenile Justice Revisions, line 156-201 by Rep. Lisonbee, 2024 UT Legislative Session

- ➤ Made the following modifications to the requirements for the juvenile gang and other violent crime prevention and intervention program:
 - USBE must coordinate with state agencies to do the following:
 - -establish a formula to allocate the funding
 - -Use data from those agencies for the formula
 - -Prioritize school districts and charter schools that demonstrate collaborative efforts with local law enforcement agencies and community prevention
 - "State Agencies" include:
 - -State Commission on Criminal and Juvenile Justice
 - -Administrative Office of the Courts
 - -Department of Corrections
 - -Division of Juvenile Justice Services



- ❖ Revise and implement the Board rule to reflect HB362 changes
- ❖ Name changed to Juvenile Gang Prevention Grant
- Grant title: 25PUJG Enhancement for At-Risks Students Gang Prevention
- ❖ Implement a 3-year grant cycle
 - > Subject to legislative appropriation
 - > Invest and allow for the program to develop and maintain
 - > Help LEAs build sustainability
 - Reduce LEA's administrative workload
- Coordinate with "State agencies" to give them a voice and input into the process



USBE Plan (Cont.)

Timeline:

- ➤ Revise and seek the Board approval of Administrative Rule R277-436 (March June, 2024)
- Announcement Competitive Grant: July 30, 2024
- Grant Due: August 30, 2024
- Grant Award notification: September 27, 2024
- > Grant implementation:
 - FY25: award date through June 30, 2025
 - FY26: award date through June 30, 2026
 - FY27: award date through June 30, 2027
- > Year-end Report of previous year's activities
 - FY25 Award: October 1, 2025
 - FY26 Award: October 1, 2026
 - FY27 Award: October 1, 2027

Grant Requirements & Qualifications

- 1. The grant is competitive and is open to all LEAs
- 2. LEAs are required to provide the following information:
 - a. targeted student population
 - b. prevention and intervention strategies beneficial to the targeted population
 - c. prevention and intervention strategies address the identified issues
 - d. collaborate with local law enforcement and prevention provider communities
 - e. articulate the LEA's plan to use Juvenile Gang Prevention Grant funds



Grant Requirements and Qualifications (Cont.)

- 3. Funding will be prioritized to be awarded to LEAs that:
 - Demonstrate collaborative efforts with law enforcement and prevention communities
 - b. Use state agencies' data to identify targeted population that demonstrate multiple risk factors for gang involved;
 - c. Have a well thought out plan on how to implement the proposed activities
 - d. Demonstrate a process to collect data and evaluate the effectiveness of the implemented activities



How to complete the Grant Application

- 1. Review <u>Utah Code 53F-2-410</u>
- 2. Review the **Board Rule 277-436**
- 3. Review and complete the <u>Juvenile Gang Prevention Grant Application</u>
 - a. UT Grants System portion
 - b. Qualtrics Survey portion
- 4. Submit the application by 5:00 PM August 30, 2024

- 1. Utah Grants Management System:
 - Grant title: 25PUJG Enhancement for At-Risks Students Gang Prevention
 - standards grant information, terms, and budget portion
 - Louis Carpio, Financial Analyst
- 1. Juvenile Gang Prevention Grant Narrative via Qualtrics Survey
 - Cuong Nguyen/Tina Morandy

Examples of Acceptable Uses of the Grant Funds

- Salaries and benefits for staff directly implementing the program
- Choose Gang Free Program
- Check & Connect Mentors/Student Advocates
- Comprehensive Gang Model, hire manager and staff to implement the program
- Professional Learning: Restorative Practices, registration fees to attend conferences in relation to youth/gang, gang-related issues such as the Utah Gang Conf., Northern Utah Gang Conf., Utah Promising Youth Conference, etc.
- Curriculum/program materials to support the implementation of evidenceinformed gang prevention/intervention programs
- Stipends for teacher/staff for developing specific subject matter expertise
- Cell phone cost and school supplies specific to the program
- Mileage reimbursement



Unallowable Expenses

- Food costs associated for the juvenile gang prevention/intervention activities
- School safety needs such as firearm detection software or metal detectors
- Capital improvements


