

USBE School Safety and Support Grant (H.B. 61)

School Safety Assessment: Top Considerations & Priorities

In alignment with House Bill 61, Local Education Agencies (LEAs) must complete an assessment to determine the need for the School Safety and Support Grant (physical safety improvements) using the Framework of Assessment, Building Capacity, Planning, Implementation, and Evaluation.

Below are top considerations and priorities to support LEAs:



2. Are there first-aid kits in the classrooms?
3. Are bleeding control kits available and readily accessible?
4. Does the school have inter-operable communication hardware, software systems?

- a. Are school staff properly trained on the use of these systems?

Facilities

1. Has the school completed a safety assessment?
 - b. Have physical security upgrade needs been identified?
 - c. Baseline considerations:
 - i. Utilization of all-hazards response technology
 - ii. Intercoms and/or two-way radios
 - iii. Panic buttons
 - iv. Locks on doors
 - v. Visitation policies
 - vi. Faculty/staff secure key card entry access
 - vii. Single or limited-point entry
 - viii. Containment hardware capabilities (i.e. security doors)
 - ix. Secure vestibules
 - x. Cameras/surveillance
 - xi. Lighting



Personnel, Training, and Programs

5. Does the school have a multidisciplinary targeted violence threat assessment team?
 - a. Is the process used evidence-based?
 - b. Has the team been properly trained?
6. Does the school have services provided by a School Resource Officer (SRO)?
 - a. Is there a Memorandum of Understanding (MOU) in place?
 - i. This should include SRO roles and responsibilities and any applicable training for that position.
7. Does law enforcement provide safety and security training for the school (i.e. drills, reunification, etc.)?
8. Standard Response Protocol (SRP)TM
 - a. Have school staff been properly trained on The I Love U Guys Foundation SRP?
 - b. Is there an MOU in place between the LEA and The I Love U Guys Foundation?
9. Does the school utilize SafeUT?
 - a. Is the point of contact list given to [SafeUT](#) up-to-date?
