


#### STATE SECURITY ORG CHART

### Department of Public Safety Channels of Information Flow



### School Safety Personnel (1)

- School Safety and Security Specialists (SSSS):
  - Every campus within an LEA shall designate a SSSS.
  - May not be the principal.
  - May be the LEA School Safety and Security Director at one campus within the LEA.
  - Report directly to the principal.
  - Ensures adherence to policies and procedures involving school safety.
  - Participation on the school's multidisciplinary team.
  - Will collaborate with the County Security Chief on the annual needs assessment.



# School Safety Personnel (2)

- LEA School Safety and Security Director (SSSD)
  - Each LEA shall appoint an LEA SSSD
    - Serve as the point of contact for the County Security Chief, local law enforcement, and the State Security Chief
  - Must have a valid concealed carry permit and participate in the training requirements for the Guardian Program
  - Ensure adherence to policies, procedures, and regulations relating to school safety
  - May temporarily fill-in for for a guardian
  - Name, contact information, and photograph will be collected by the State Security Chief
    - Information will be readily available for law enforcement needs



### School Guardian (1)

- An LEA shall ensure each school in the LEA has at least one of the following:
  - School Resource Officer
  - School Guardian
  - Armed School Security Officer

### School Guardian (2)

- A school guardian is a school employee who volunteers for the role and meets the following requirements:
  - School administrator approves the employee to enter the program.
  - Completes the School Guardian Training Program within six months of taking on the role.
  - Holds a valid concealed carry permit.
  - Successfully completes a mental health screening selected by the State Security Chief in collaboration with Office of Substance Use and Mental Health.

### Guardian Mental Health Assessment (1)

Guardian Selection Process:

"New Guardians must pass a 'fit to carry assessment' prior to commencing their duties."

Guardian Annual Recertification:

"Existing Guardians must participate in at least one mental health screening per calendar year as part of the annual recertification requirements."



### Guardian Mental Health Assessment (2)

- The term "fit to carry assessment" be defined in state statute as:
  - "A series of psychological tests administered by a professional with Level C qualification to include:
    - 1. a personality assessment,
    - 2. a symptoms screener,
    - 3. an in person interview, and
    - 4. a reference check of at least one reference provided by the Guardian."

### School Guardian (3)

- The State Security Chief will:
  - Track each school guardian participating in the program
    - Name, contact information, and photograph
  - Make guardian information readily available to local law enforcement in the event of an emergency
  - Provide a one-time stipend of \$500 to each guardian
- Guardian information is private, controlled, and protected
  - May only be known to:
    - State Security Chief
    - County Security Chief
    - School Administrator
    - Local law enforcement
    - Other school safety personnel
  - Individual who knowingly or intentionally provides information is guilty of a class B misdemeanor



# School Guardian Training Program

- School Guardian Training Program;
  - Has been released to the County Security Chiefs

### Application for Alternatives

- LEAs may apply to the State Security Chief for alternatives based upon the following considerations:
  - Population size
  - Staffing needs or capacity
  - Geographic location
  - general demonstration of need for an alternative
- Predetermined exceptions:
  - Enrollment size fewer than 350:
    - Same individual may serve in more than one role
  - Enrollment fewer than 100:
    - "School Employee" may be a teacher or principal



### School Safety Needs Assessment

Utah Code Section 53G-8-701.5 requires:

- Each school to conduct a school safety needs assessment.
- Report the results of the school safety needs assessment for each school to the State Security Chief and the School Safety Center.
- The results will be used to award a grant to an LEA in accordance with 53F-5-220.

### Submitting Results of Your Assessment

- Summarized results of your school safety needs assessment will be submitted through a Qualtrics link provided through your LEA.
- LEAs will be provided training and support to setup the School Safety Needs Assessment Summary Form in their Qualtrics account.
- An application for alternatives will be considered by the State Security Chief.
