# Annual Report on Providers Statewide Online Education Program School Year 2023-2024

## Introduction

The Utah State Board of Education (USBE) is required to report on the performance of authorized online course providers. Performance for this report includes:

- 1. Completion of courses within the period specified by the law, which is a calculation of courses in which the student had completed the course with a passing grade, and the grade and credit earned was sent to the student's primary school divided by courses in which the students were:
  - a. Active in a course at "Census" (the day after the 20th day after the student started the course), and
  - b. had not asked to withdraw, and
  - c. had not been withdrawn for administrative or disciplinary reasons before the course ended.

This is reported as a percentage.

- 2. Pupil to teacher ratio
  - a. This is the total number of students enrolled with a provider divided by the total number of full-time teachers employed by the school.
  - b. This ratio measures the number of teachers for all students, regardless of whether a student is a regularly enrolled student at the school or is only taking the school's courses through SOEP.

**Note:** For the reports below NA is indicated if the school was not in-service for the year reported.





## **SOEP and State Assessment Performance**

The figure below shows the percentage of SOEP students, by subject area, who were proficient in end-of-grade level assessment for ninth and tenth grade students in English, Math, Reading, and Science, for the 2023-24 school year. These results are only for students who were enrolled during a testing window and who did not opt out of testing, as allowed by law. Only students who took SOEP courses in these subjects, who were enrolled during testing, and who completed the assessment in Utah Aspire Plus are included. The chart represents the percentage of proficient SOEP students by subject area for 2023-24 [1].
